**42/18 REQUEST FOR NOMINATIONS FOR OAKHAM TOWN TASK AND FINISH GROUP (*Appendix B*)**

Nominations were invited for a representative for the Task and Finish Group. It was agreed that members would vote by a show of hands.

- (i) It was proposed by Cllr Romney, seconded by Cllr Buxton to elect Cllr Skipworth
- (ii) It was proposed by Cllr Brookes, seconded by Cllr Wadsworth to elect Cllr Woodley
- (iii) It was proposed by Cllr Lowe, seconded by Cllr Ind to elect Cllr Lowe
- (iv) The first vote was 3 votes for Cllr Skipworth, 4 votes for Cllr Woodley and 3 votes for Cllr Lowe  
Due to the equality of votes, the Chairman used his casting vote and therefore Cllr Lowe received 4 votes. Cllr Skipworth received the least votes, as a result, a further show of hands was requested with just Cllr Woodley and Cllr Lowe being nominated
- (v) The second vote was 5 votes for Cllr Woodley and 5 votes for Cllr Lowe. Due to the equality of votes, the Chairman used his casting vote and therefore Cllr Woodley was duly nominated
