

1 Respective responsibilities of the body and the auditor

Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- Section 1, Assertion 5 has been incorrectly completed. Information received from the smaller authority and the internal auditor confirms that no risk assessment was performed during the year under review and hence the correct response to this assertion should be 'no.' It should be noted however, that the council is currently undergoing a review of its risk management procedures in 2018/19.
