#### 213/18 DEPUTATIONS BY THE PUBLIC

#### 214/18 RUTLAND HOUSE COMMUNITY TRUST

- (i) As per Standing Order 6 (f) the Chairman proposed to agree in principle for an additional care home for 8 residents plus alterations to existing care home to create 7 independent apartments as per the planning application, and it was seconded by Cllr Brookes to allow for debate. Councillors discussed the proposal. An amendment was proposed by Cllr Brookes and seconded by Cllr Clough that the plans for the building be agreed but permission not given for additional roadway and parking on the site to allow for more amenity land. Therefore, the motion as amended was then proposed by Cllr Brookes and seconded by Cllr Denyer and approved with 5 votes for, 3 against and 2 abstentions.
- (i) Proposed by Cllr Lowe, seconded by Cllr Brookes and unanimously resolved that Council on behalf of the resident's, ask RHCT to take into consideration their concerns and ensure a suitable screen of trees. This will be incorporated into their lease and will be managed and the responsibility of RHCT
- (ii) Proposed by Cllr Brookes, seconded by Cllr Clough and resolved by 8 votes for, 1 against and 1 abstention that the Working Group continues to review the land rent with RHCT and any variation to the lease
- (iii) Proposed by Cllr Brookes, seconded by Cllr Wadsworth and resolved with 5 votes for, 1 against and 4 abstentions that Cllr Brookes is elected onto the Working Group
- (iv) Proposed by Cllr Brookes, seconded by Cllr Wadsworth and resolved with 9 votes for, and 1 abstention that Council grants permission for the Clerk to instruct a Solicitor, a land valuation and approves any associated expenditure
