#### Part 2: A Description of your idea

#### What do you want to do?

We are applying for funds to support a series of six workshops in Oakham for people with dementia. The total cost is £4,400. We are asking for £3,600.

Evidence shows that people in their 50s and 60s who have a diagnosis of young-onset dementia or older individuals with early-stage disease are able to slow the progress of their condition by participating in practical creative activities. And there is a similar body of work which demonstrates the benefits of such activities on the relationship between the person with dementia and their carer.

Consequently, in 2019 RCV began organising practical and creative "New Memories -Creative Experiences" (NM-CE) workshops in local venues with the aim of supporting people living at home with a dementia diagnosis, their loved ones, and those who care for them.

These have been successful, oversubscribed and of tangible and demonstrable benefits to participants.

To date, we have run four series of NM-CE workshops – each different from the other. either in location or content – and funding so far has been raised by Rutland Community Ventures from local councils, businesses, charitable organisations and other groups and individuals.

We are now raising funds to run workshops in 2020 to continue with this initiative, hence this request for a grant from Oakham Town Council.

#### Part 3: Your Community

#### Who would benefit from your project?

Dementia usually affects older people and Rutland's demographic skews toward this group. By 2025 Rutland will have the highest proportion of over 80s in the UK. Currently 350÷ people in Rutland have dementia and an estimated hidden group of about the same size lives at home. People with a dementia diagnosis living at home with a carer or loved one will benefit from this project.

People with young-onset or early-stage dementia living at home can be overlooked or hard to reach. They are often vigorous, fit and understandably unwilling to identify with an elderly care-home-based stereotype. They are also often unwilling to leave the house. Consequently, they — and their carers/loved ones — can become isolated and depressed, losing confidence and missing the social interaction which can help them cope. NM-CE works to reverse this by offering opportunities to get out of the house, become engaged once more in a previously-loved activity or learning something new. And while this is happening, more conventional support services can be brought to bear.

#### What difference will your project make?

The project has made an enormous difference to participants over the last year.

Listen to some beneficiaries:

"Formerly a very shy man he grew into the group and enjoyed the interaction. [And he] enjoyed talking about it to others outside the group."

"As a carer I would like to say how valuable the workshops are. They are an opportunity to socialise with new people who understand how complex and challenging coping with dementia can be."

"I love coming to these workshops. It's a chance to distance myself from the challenges for a while..."

"The fact that not mentioning 'dementia' is accepted means that those with problems don't feel in any way demeaned or pressurised to achieve what they have difficulty with."

"All the staff and providers of the workshops are exceptionally good and sensitive in their approach and lovely to spend time with. On behalf of both of us I would like to say a big 'thank you'."

"The workshops have given my husband something to focus on and look forward to, and even try newfound skills at home!"

We make videos of all our sessions so that participants with memory loss or poor retention can be reminded of what they have been doing and thereby benefit again from the activity. A beneficial side-effect of this is our ability to create a video showcase showing the sessions. See for yourself...

#### Part 4: Monitoring

#### How will you monitor the project once it has started?

At a Company level, Rutland Community Ventures is a Company Limited by Guarantee, and part of our governance process is monitoring by an independent Advisory Committee. This group comprises three individuals who are representative of our community. They meet formally on a regular basis to offer advice, guidance and financial monitoring. Their role is to act as a 'critical friend' of the company. We are also in frequent communication with the Advisory Group members between meetings.

In addition to this personal monitoring, the company has a set of policies covering areas such as Privacy, Equality and Safeguarding. We also have a code of conduct covering our staff, including volunteers.

Turning to Project monitoring, we have in the past received public funds, charitable donations and grant aid from bodies such as the Lottery Heritage and Armed Forces Covenant Trust Funds. Consequently, we are accustomed to meeting the project monitoring requirements of the bodies from whom we receive grant aid.

Financial matters are controlled through our Quickbooks accounting system, and progress against project goals and outcomes requirements is monitored at weekly team meetings. We also collect attendance numbers and feedback from both our participants and volunteers. In some cases, where required, we operate monthly reporting to our sponsors.

#### Have you applied for funding from anywhere else? Please give details

We have not applied to anyone else for funds to support this series of workshops.

We are however trying to raise funds to cover additional series throughout the year. Consequently, in addition to applying to Oakham Town Council we have submitted an application to the Charitable Foundation for Leicestershire and Rutland and will continue to apply for grants elsewhere until we have sufficient funding for the whole year.

If our application to you is successful, the first series will run regardless of the outcome of any other application we make for funding elsewhere.

## Please give an approximate breakdown, if applicable, of how you expect to spend the money:

One series of six two-hour sessions led by professional and qualified leaders can be delivered for a grant of £3,600. This covers places for 20 participants - 10 'duos' comprising a person with a dementia diagnosis and their carer/loved one. This equates to a total of 240 hours of valuable engagement and support for those participating over the series, which leads to an individual cost per head of only £15 per hour - less than the cost of a music lesson, window cleaner or gardener, for example.

The £3,600 covers the cost of:

- a dementia-trained professional artist/workshop leader;
- delivering a verifiably successful workshop model which really does help those attending;
- the workshop leaders' materials and consumables;
- RCV providing publicity & social media, administration, promotional activities, project set up, session management, quality assurance and evaluation;
- attendance at every session by a member of RCV staff with an advanced DBS check
- recruiting and managing volunteer help;
- refreshments.

The cost of room hire is not included because it varies greatly from venue to venue. For example, Oakham Castle charges £120 per session but the Commodore's Room at Rutland Sailing Club is free of charge. We would of course hope to find the latter in Oakham – as we did in Uppingham.

# If your application is unsuccessful, are funds available to ensure your project goes ahead? If yes, please give details:

The project will not go ahead if this application is unsuccessful because we do not have funds to run a new series of workshops without help.

Clearly, we hope that the Town Council will make an award of the full amount and thereby guarantee that the first series of workshops can run. However, if you are unable to fund an entire series, we hope that you would agree to our seeking an additional partner so that the series can run later in the year.


