Strategic Aim:	

Council are responsible for the public conveniences in Church Street. Part of the legal requirement, Council must employ a provider who has a Waste Carriers certificate in order to dispose of the sanitary and nappy waste.

Since 2014, Council have instructed Phs Group to carry out this facility, at a cost of £132.79 per month.

On a number of occasions, Phs Group have failed to carry out their obligations and our Toilet Maintenance Contractor has provided this service at no extra cost to Council.

Recommendations

I therefore recommend that the provision of sanitary disposal bins is aligned with the Cleaning Contract and appoint AA Cleaning to provide this service at an additional cost of £9.21 per month

Quotation: Removal of all sanitary waste from the Church Street Public Toilet, facility based in Church Street, Oakham.

- Supply 3 Eclipse Sanitary disposal bins with white bags to the ladies facility units based at the rear of the building.
- Supply 2 E-Bin (plus) 50 litre nappy bins to both disabled toilet and baby changing room.
- Supply yellow and white waste bags to all waste collection bins
- 3 heavy duty white plastic bins to be cleaned emptied and replaced every 14 days in each female cubicle
- Supply and fit microburst automatic air freshener dispensers to both the ladies and gents ensuring an odour free environment

All staff members operating at the Church Street facility have been fully trained and hold a Waste Carriers License and will co-operate with the removal of such items every 14 days and taken for disposal.

Our charges are £142.00 per month, thus making a total of £1,704.00 per annum, fully inclusive.

We sincerely hope this quotation meets with our town Councils budgetary requirements and eagerly await your response
