- a) A verbal report was received from Cllr Lowe advising members on a response from Historic England regarding the pre-application stage of the erection of a new pavilion in Cutts Close. Historic England had advised they would be unable to support the building on the Scheduled Monument. Members noted the outcome and Cllr Romney thanked Cllr Lowe for all his efforts
- b) A verbal report was given by Cllr Romney regarding the successful park events and good feedback he had received

Noted. A verbal report was given by Cllr Burton on correspondence he had received by a business owner regarding a review on parking permits in the town centre

It was proposed by Cllr Burton, seconded by Cllr Orchard, and unanimously resolved to approve the expenditure and statement of accounts to 31st July 2021 and to note the budget report showing expenditure for the year to date

187/21 AUTHORISATION TO PAY AN INVOICE OVER £5000

It was proposed by Cllr Lowe, seconded by Cllr Orchard, and unanimously resolved to authorise the payment of Invoice No 100365, £14380 + VAT for The Christmas Decorators, for 50% confirmation to proceed

188/21 APPOINTMENT OF STANDING COMMITTEES

It was proposed by Cllr Burton, seconded by Cllr Orchard, and unanimously resolved to appoint Cllr Nix to the Staffing and Finance Committee

189/21 TO CONSIDER GRANT-AID APPLICATION -OAKHAM TEAM MINISTRY

It was proposed by Cllr Orchard, seconded by Cllr Burton, and unanimously resolved to approve £1000 to support funding for the repair to the church bells and agree expenditure of up to £1500 for any shortfall in the funding from the Diocesan Ringing Guild

190/21 OAKHAM COMMUNITY CENTRE - CCTV SYSTEM

It was proposed by Cllr Orchard, seconded by Cllr Burton, and unanimously resolved that Council would not be willing to contribute to the installation of a CCTV system at this time, however would seek recommendations from a security company for a solution and alternative options, due to the increase of anti-social behaviour and youths clambering on the roof. Proposed by Cllr Orchard, seconded by Cllr Nix, and unanimously resolved to grant Cllr Gilbody permission to act on Councils behalf with further investigation work

191/21 LORD LIEUTENANT'S CELEBRATION EVENT

A verbal update was given by Cllr Burton regarding the proposed event to mark the efforts of essential key workers and service personnel in the Armed Forces, and highlighted the issue of preliminary funding discussions to identify financial requirements

Fell 1 no. Swedish White Beam. The tree is between 18-21 metres high and has been confirmed as dangerous by two arboriculturists. Due to the current and ongoing level of disease, the tree has developed several cracks of between 1-1.3 metres up the trunk, large holes at the base of the trunk (which is hollow) and a large hole about 3.5 metres up the

trunk. It has been confirmed it will fall because of the condition it is now in, this tree is a clear and imminent risk to property and life due to its location and level of disease Recommend Approval
